- 1. Welcome, Receive Apologies for absence Paul Mills, Vice-Chair (PM) and Receive declarations of interest or requests for dispensation None were received.
- 2. Receive and approve Minutes of Parish Council Minutes held Tuesday 14<sup>th</sup> March 2023 Resolved: Minutes of the Meeting had been circulated and agreed prior to the Meeting and were signed by the Chair. The full Minutes of the Meeting will be available to view on the PC Website.
- 3. Representation from Members from the public for any items not listed in the Agenda

A Representation from a Parishioner regarding full ditches and lack of soakaway for surface water near the Church and water collecting on the road beyond, was discussed. The historic drainage was discussed and Councillors are due to go and look at the problem near to The Church and bridleway and the ongoing issue of drains clearance by WC which has been repeatedly raised and requested as urgent.

### 4. Matters Arising/ outstanding.

Drainage from the old Village Hall and the village drainage system. A member of the community reported to the Clerk before the March meeting that the drains may be connected to his property and he raised a question about roof felt coming through to his drains. Councillors and PRH were able to access the VH and make sure that all drains are covered and roof checked and secured as well as possible.

PRH discussed an asbestos removal quotation has been obtained and 2 other quotations have been sought.

- Banks erosion on The Hollow Ongoing: PO is due to address this at the Open Meeting on 16<sup>th</sup> May 2023.
- Parking for Small Street CC has requested to Aster that they cut back/down the trees causing an issue for residents wishing to use the parking bays in Thumbwood Terrace.

# 5. Pewsey CATG /LHFIG

• Issue 10-22-7 (C&CPC 13/12/22 Item 91) Bollard protection for verge erosion to land in front of church.

In a meeting in February between the PC Councillors and Highways (to address local concerns) at the verge outside the Church, action to change the new placement of 4 bollards/posts was requested. Further discussion and an estimate of costs are due to be raised at the Meeting of LHFIG on 26<sup>th</sup> April 2023. A

post on the path has already been removed and the PC has requested to Highways that 2 posts remain either side of the church path and every other post be removed. The PC await the outcome from the LHFIG Meeting.

It has been communicated by the Clerk to the community via email, the Redhorn Magazine and on Facebook that WC Bollards/posts are approved roadside furniture and stones and other such items, are not approved and as such we, The Parish Council are bound by official standards.

Issue 037-008 – C241 Small Street, Chirton 037-009 – C51 The Hollow, Chirton Ongoing: Chirton 20 mph speed limit assessment. On 31.1.23 Speed tracking was fitted in two locations in the Village PM – was not present at the April PC Meeting however on 8.3.23 he reported that the findings of the initial speed assessment suggested that, based on the average speed for each location, speed watch is not a solution, where as a 20mph limit may well be. We now need to take to LHFIG for advice as to request a full survey at a cost of approximately £2,500 if LHFIG feels a 20mph limit request is likely outcome. This Item is also due for discussion at the Next PC Meeting on Tuesday 16<sup>th</sup> May 2023.
