Part I

Welcome, Apologies for absence - Cllr. Paul Oatway and receive declarations of interest or requests for dispensation - None were received.

35 Resolved: Receive and approve Minutes of :

- Annual Parish Council Meeting held on Tuesday 16th May 2023.
- Annual Parish Open Meeting held on Tuesday 16th May 2023
 Chair (PRH) received and signed the Full Minutes of above Meetings, available to view on the Parish Council Website.
- Representations from Members of the Public. For any items not listed on Agenda.

 Matters Arising/Outstanding from previous Meetings were discussed, in summary, below:
- The boundary line of the hedge opposite the bend on The Street opposite The Church and allowable width of highway overgrowth has been exceeded and traffic is moving out into the centre of the highway to avoid it. The road traffic signage for vehicles to slow down, it was reported is also concealed by overgrowth. Measures to rectify this and a request to assist from the PC to Wiltshire Council, has been made and is in hand. Action: PM/PRH
- Representation from a Parishioner regarding traffic and parking problems caused at key times of the School day on both sides of the highway, from The Hollow and along the length of The Street, require the co-operation of all to be vigilant to through traffic and the dangers to pedestrians, parents and especially children. The Chair, PC and school have met and discussions of possible measures to mitigate incident and the PC's support is ongoing. (Minutes 8.3.22 item 165). It was discussed that extended school (staff) parking on-site would be the solution, however we are aware that funding for the School is an issue as part of the EQUA MAT they are outside of WC authority area. The school also informed the PC that 11 pupils are in fact joining the role (not 20), in September and there will be leavers. The PC's reinstatement and extension of Footpath (CHIR 17) from (CHIR8) to the rear of the school and continuing parallel to The Hollow, has been agreed, (item 41 below) in a continued drive to provide an alternative walking route away from the traffic. The PC have informed school, about the safety concerns from the village, and another request has been made to ask parents to park considerately. Action: Clerk.

- A Parishioner requested that consideration be given to a highways safety issue at the steep approach from The Hollow onto the A342 and that sensor traffic lights with priority to the A Road and speed reduction from both approaches into the Village on the A342, would aid safe access for vehicles onto the A342 and where visibility over verges has been reduced due in part to the development of The Old Wiltshire Yeoman. An application to Highways is to be agreed but would at this stage be supported by all Councillors. Action: Clerk to draft Highways request/ALL
- A report that was posted by the PC onto Facebook following incidents last month of a cyclist following village resident's home, has been reported and the police presence has been visible. We are advised that this is an issue to be addressed by the police with respect to care in the community.
- A Member of the Parish spoke regarding his request at the Parish Open Meeting for a Footpath alongside the A342 from Chirton to Stert. The path that exists from Stert to Devizes, which is overgrown in places, is out of area for Cllr. Oatway. However, he did say that he would support an application from Chirton PC. PM suggested that the existing footpath/Byway route running approximately parallel to A342 could be taken to the western exit of Wedhampton and a creation of a footpath to Lydeway and further to the Bridge before the old Clock Inn, Stert Valley would be beneficial. The cost of the works carried out on the small stretch in front of the Old Yeoman site was shared and the Clerk reported that The Urchfont PC had been informed of the need for a footpath at least from Wedhampton to Lydeway.
- **Resolved:** Vice-Chair agreed prior to Annual PC Meeting to stand for office for Year 2023/24 and was duly elected by unanimous agreement (16.5.23 Item 16). Due to absence at last meeting, the Acceptance of Office was signed, in presence of the proper officer.
